

2008 SAVIR Accomplishments

(1) Ensure continuity of SAVIR Leadership

- Nominations committee considered and personally communicated with 14 total candidates for President Elect and the Board of Directors.
- Established and changed the SAVIR Bylaws to allow for one-year President-Elect, President, and Past-President elected positions
- Board elected a new SAVIR President-Elect
- General membership elected and placed 6 new SAVIR Board of Directors members in two separate elections

(2) Complete an enhanced membership drive

- Revision of all membership recruitment materials
- Development of membership recruitment brochure
- Recruitment letters sent out to all US Youth Violence Centers, Suicide Prevention Centers, and Level 1 Trauma Centers
- SAVIR Center dues structure revised to incentive new Center and individual members resulting in a 25% increase in Center membership

(3) Form a new SAVIR Council of Centers

- Election of Council Chair
- 1st Council of Centers Annual meeting
- Council of Center membership drive
- Development of RFP for SAVIR bi-yearly conference
- Engineered a 25% increase in Center membership
- Formalized application process established whereby the Council vets and votes on SAVIR Center member applicants as future sponsors of SAVIR National Injury and Violence Research conferences
- Two Center members confirmed as hosts of future SAVIR National Injury and Violence Research conferences – University of Iowa in 2011 and Johns Hopkins University in 2013

(4) Plan the 2009 and future National Injury & Violence Research Conferences

- Two day conference planned, scheduled, and ready to be implemented in Atlanta Georgia
- Co-sponsored by Emory University Injury Research Center and the NCIPC
- Includes multiple keynote speakers, oral research sessions, and poster research sessions
- Also includes 1 day of pre-conference training workshops on: (1) advocacy and (2) public health competencies
- Two Center members confirmed as hosts of future SAVIR National Injury and Violence Research conferences – University of Iowa in 2011 and Johns Hopkins University in 2013

(5) Form a new SAVIR Sustainability Committee

- Hiring of professional fundraiser
- Designed and developed the first year's Fundraising Plan
- Fundraising mailing
- Design and produce the first Board Resource Development Training in October 2008

(6) Make advocacy and outreach high priorities

- New Advocacy Alert process developed and approved by the SAVIR Board
- Multiple advocacy Alerts sent to members
- Support of Congressional staff briefings, including with CDC Director Julie Gerberding & NCIPC Director Ileana Arias.
- Visits to Congressional staffers to raise awareness and increase funding dedicated to injury research.
- Written support of the Campaign for Public Health for new Congressional appropriations to injury research.
- Article from SAVIR on injury research advocacy in the BMJ journal Injury Prevention.
- Written support of the NIH Translating Research into Public Policy for Population Health (TRIPP) initiative.
- Written support of Falls Free Coalition Congressional request to fund falls research.
- Written support of the CDC's NCIPC for their Coordinated Communications Project.
- In-person contributions and representation as well as written support of the CDC's NCHS for the activity status of E-codes for military operations.
